He is M.A., LLB, CAIB, MBA (HR) & PhD.

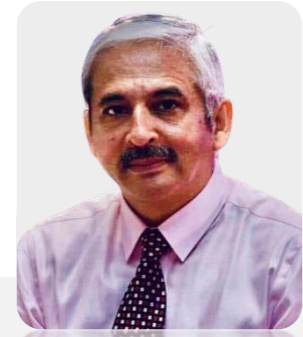
